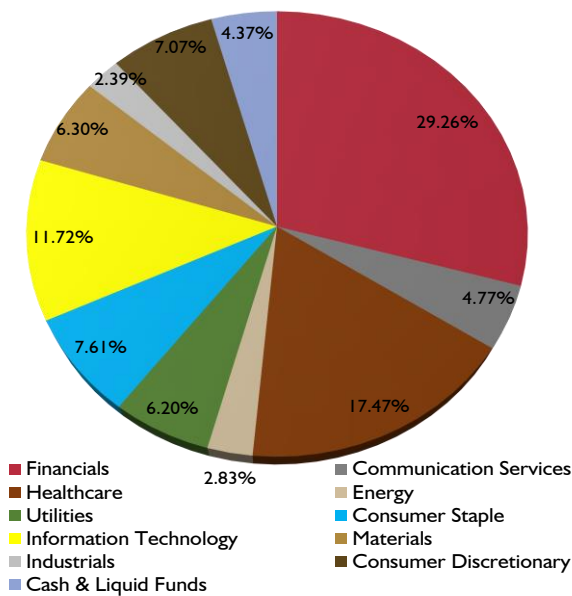

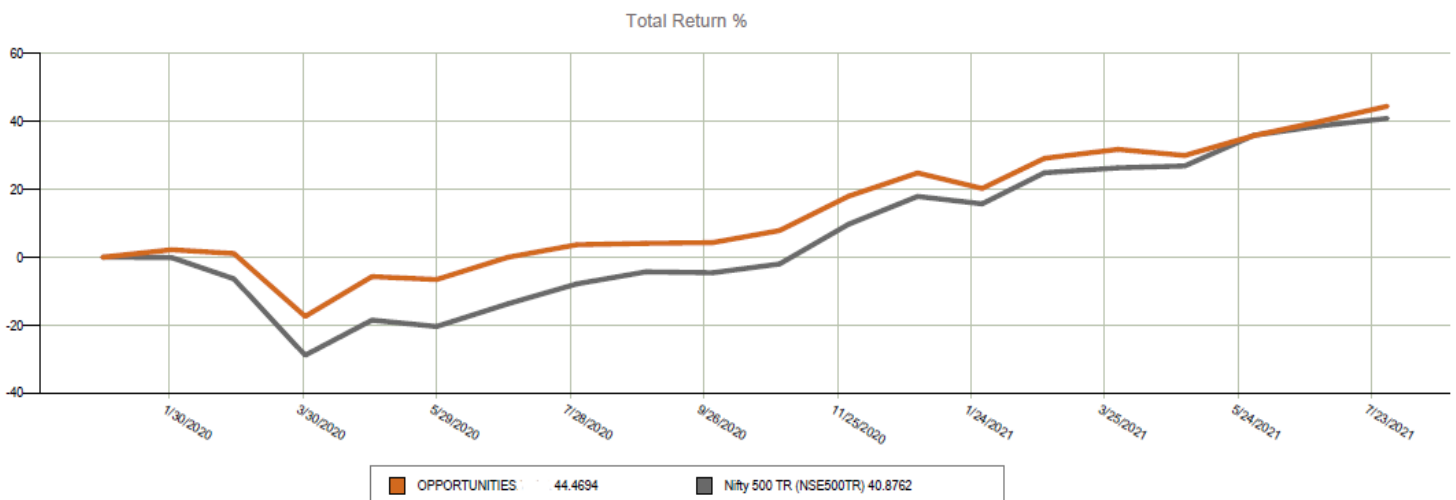

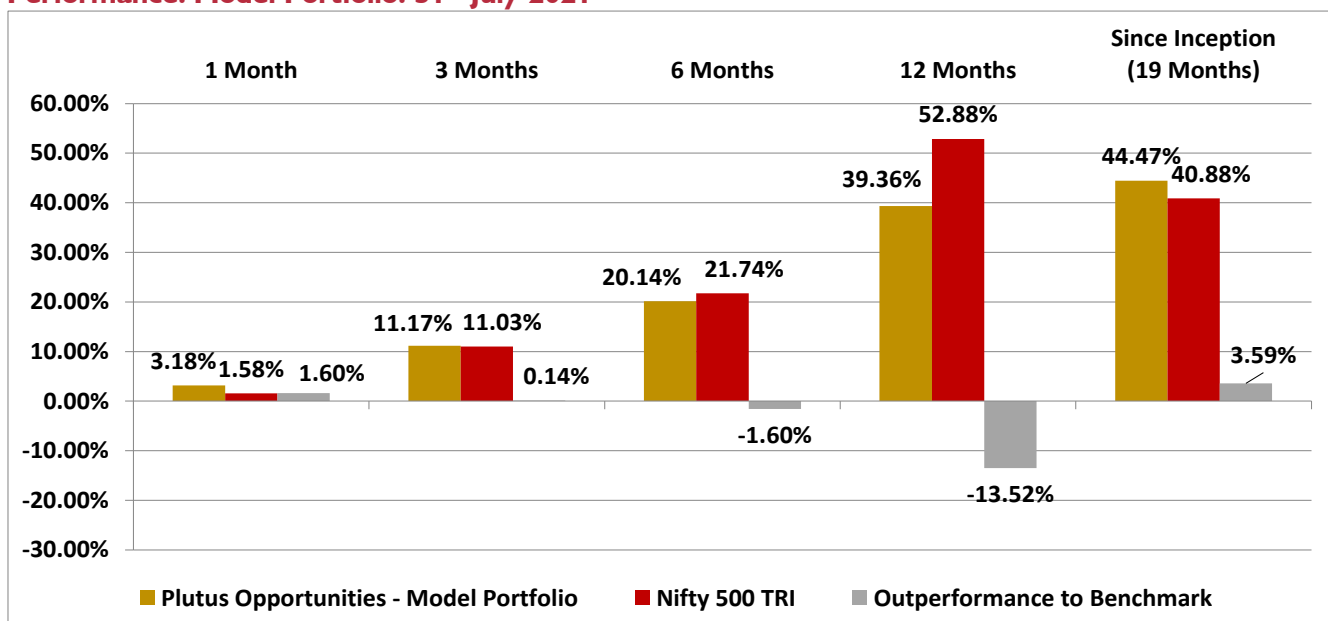

Performance: Model Portfolio: 31st-July-2021

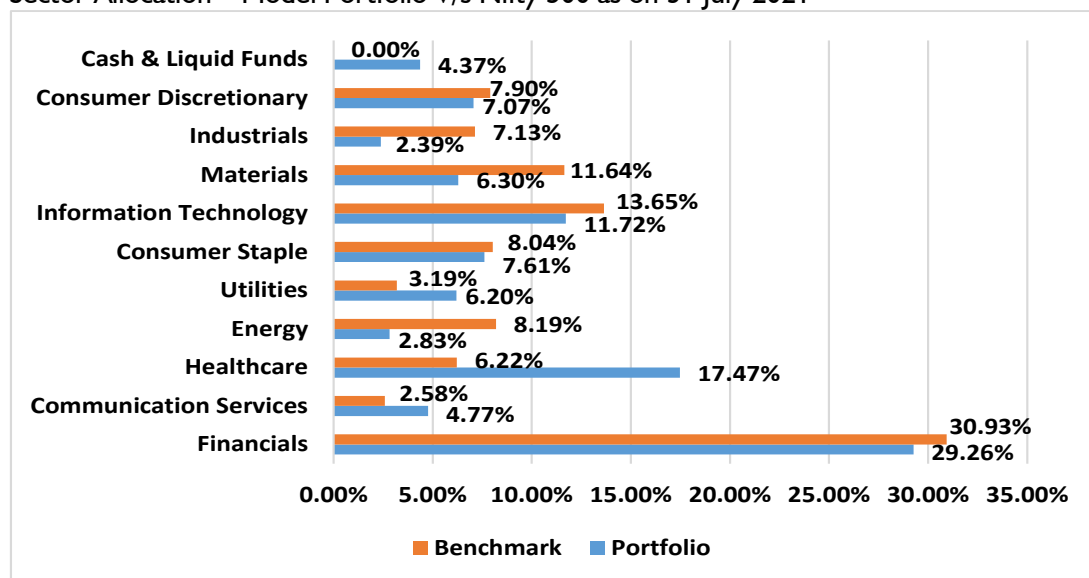

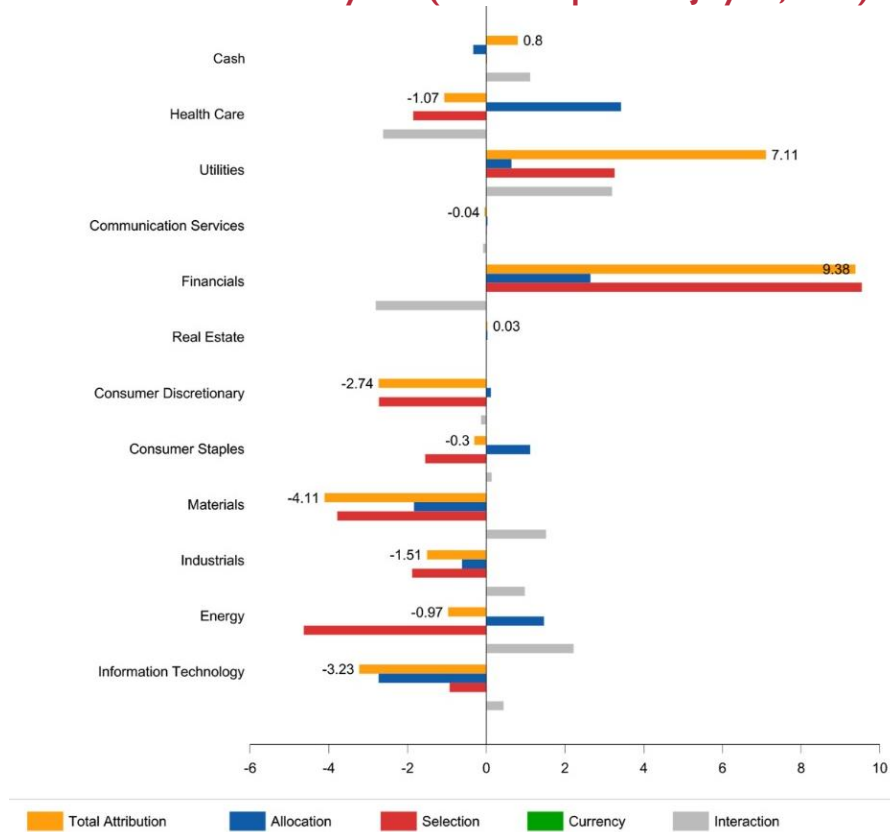
