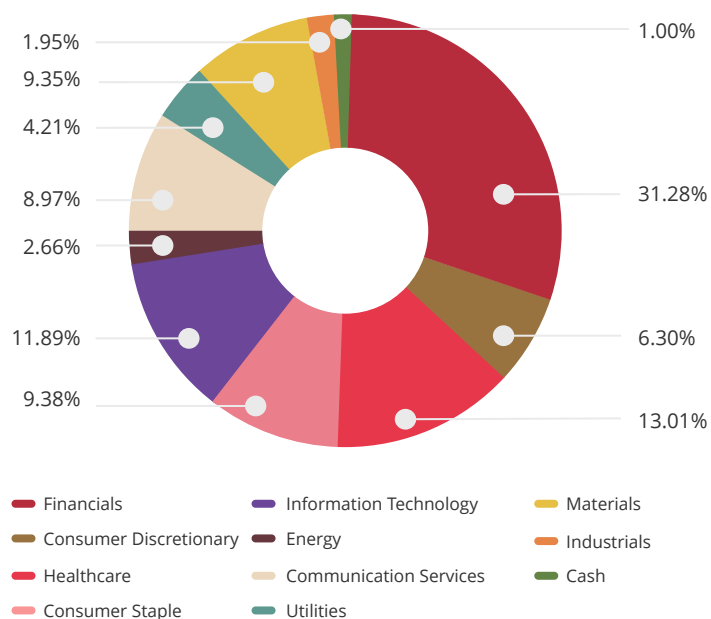

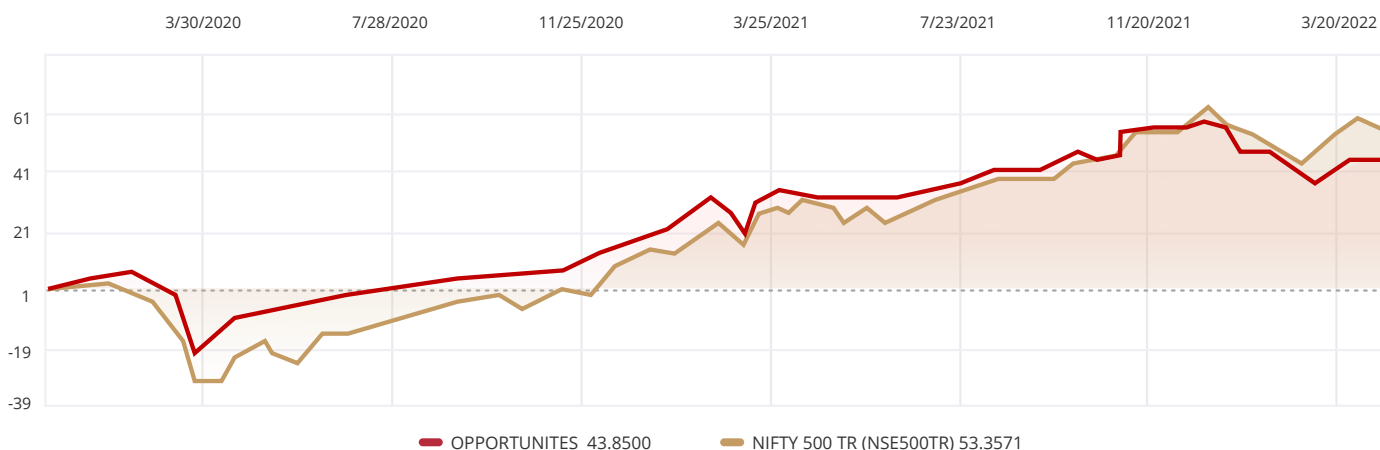

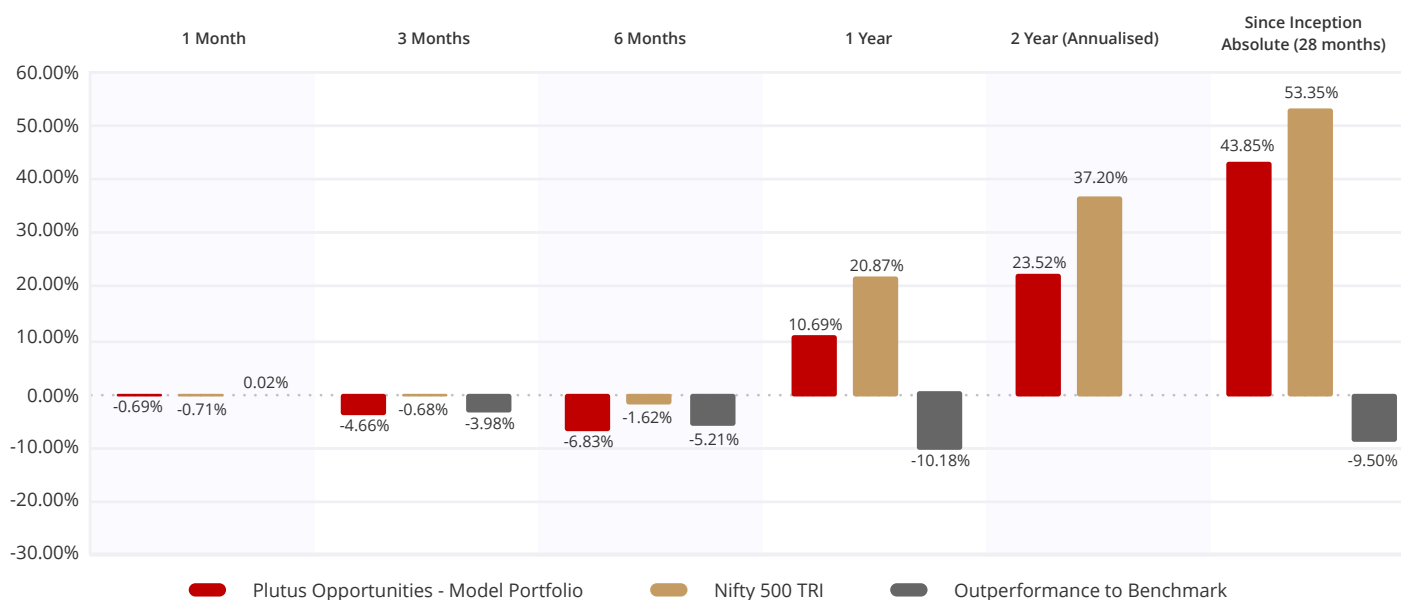
Sector* Allocation Model Portfolio weight - 30 April, 2022

Performance: Model Portfolio – 30 April, 2022

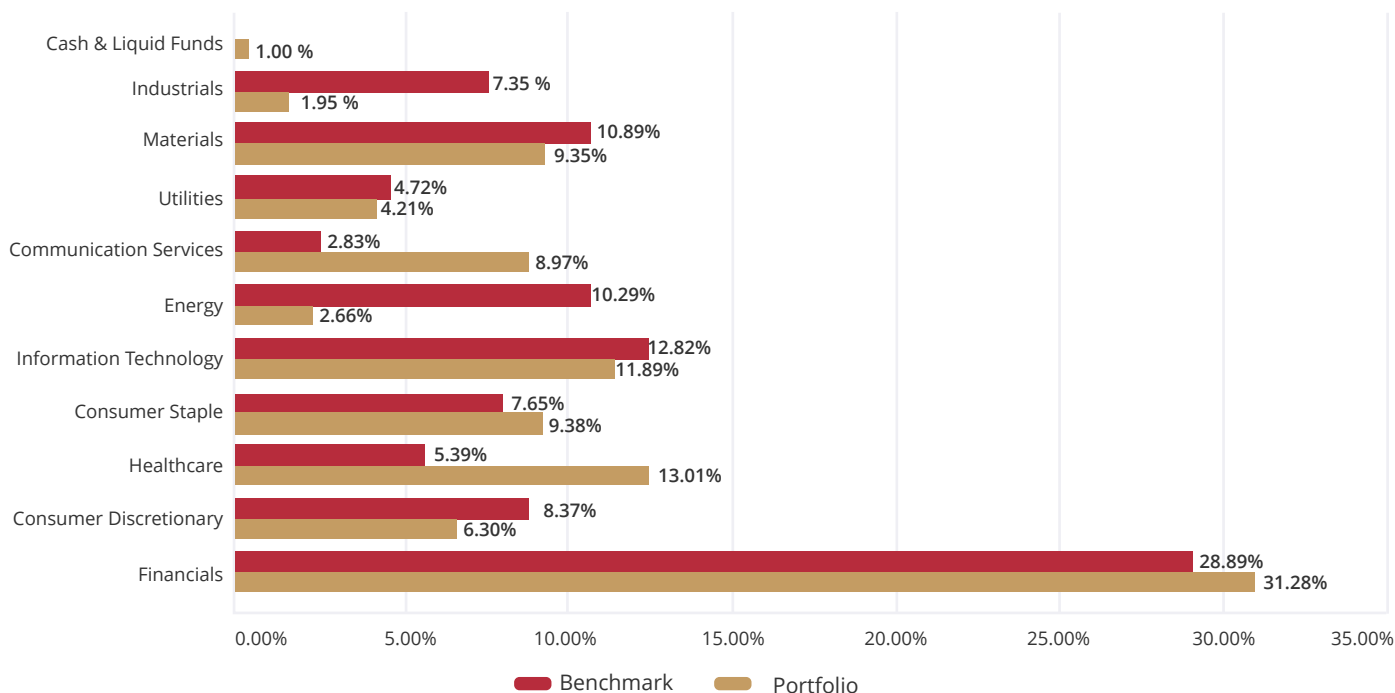

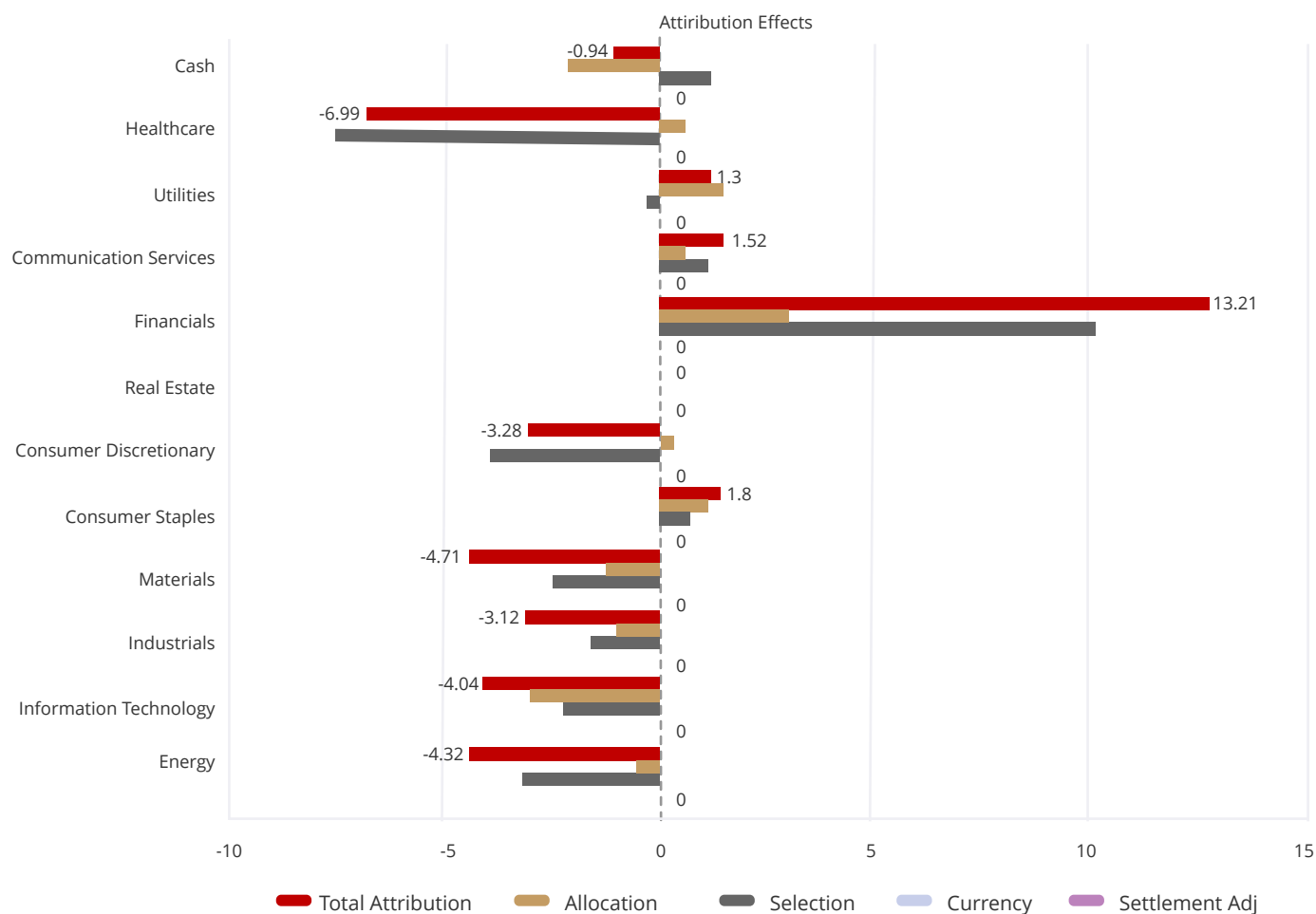
