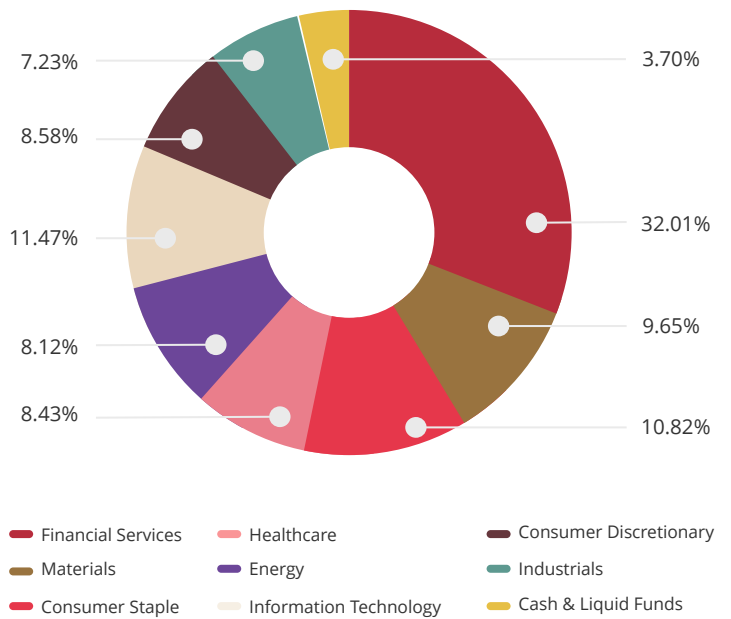

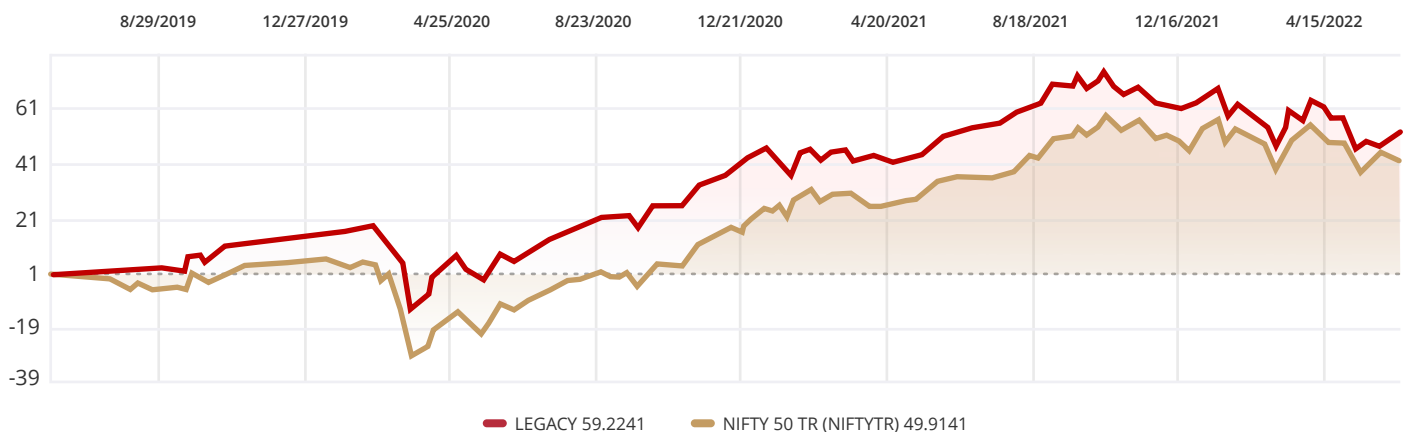

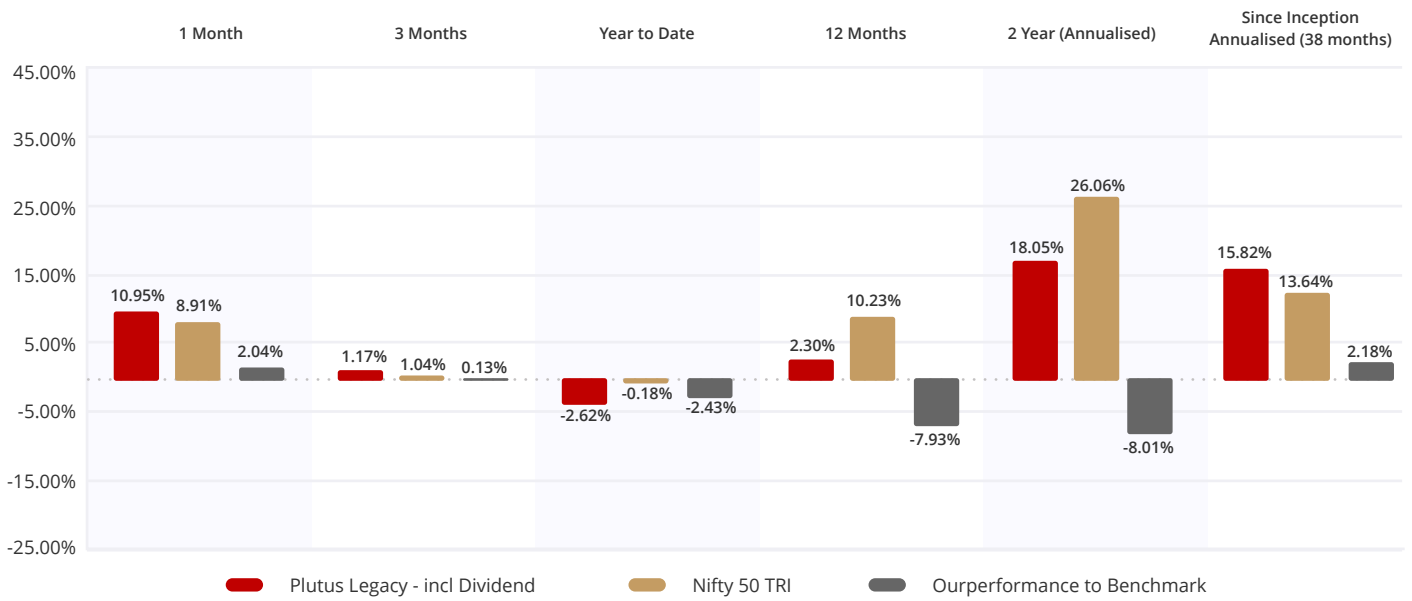
Model Portfolio weight: 31 July, 2022

Performance: Model Portfolio - 31 July, 2022

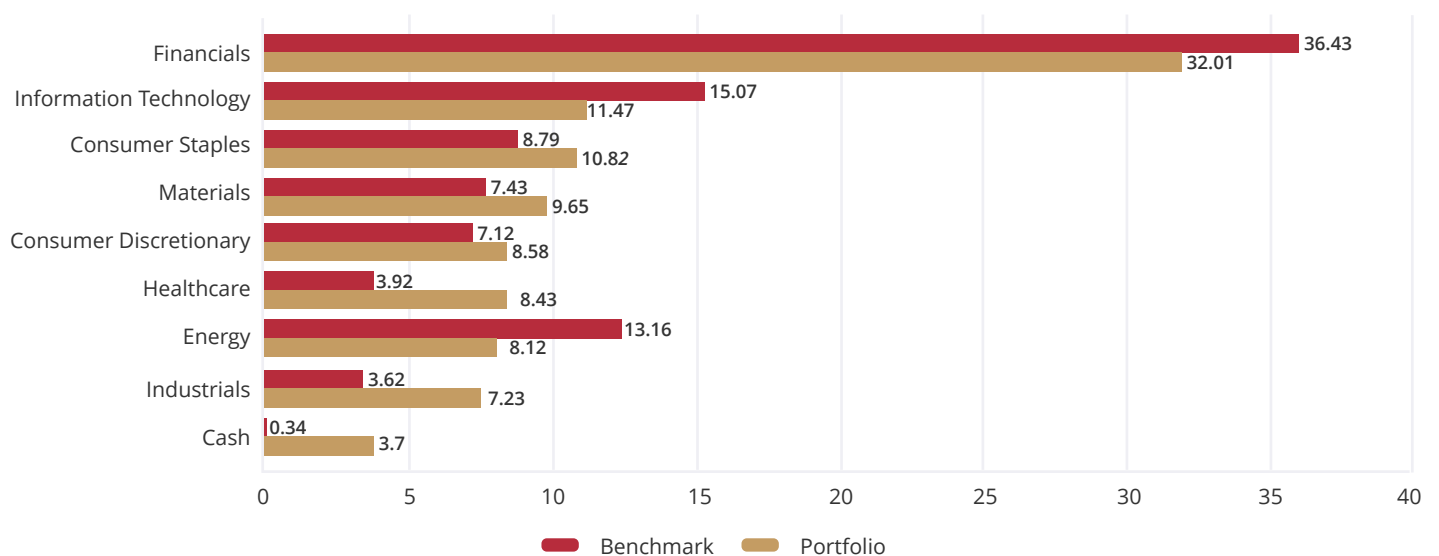

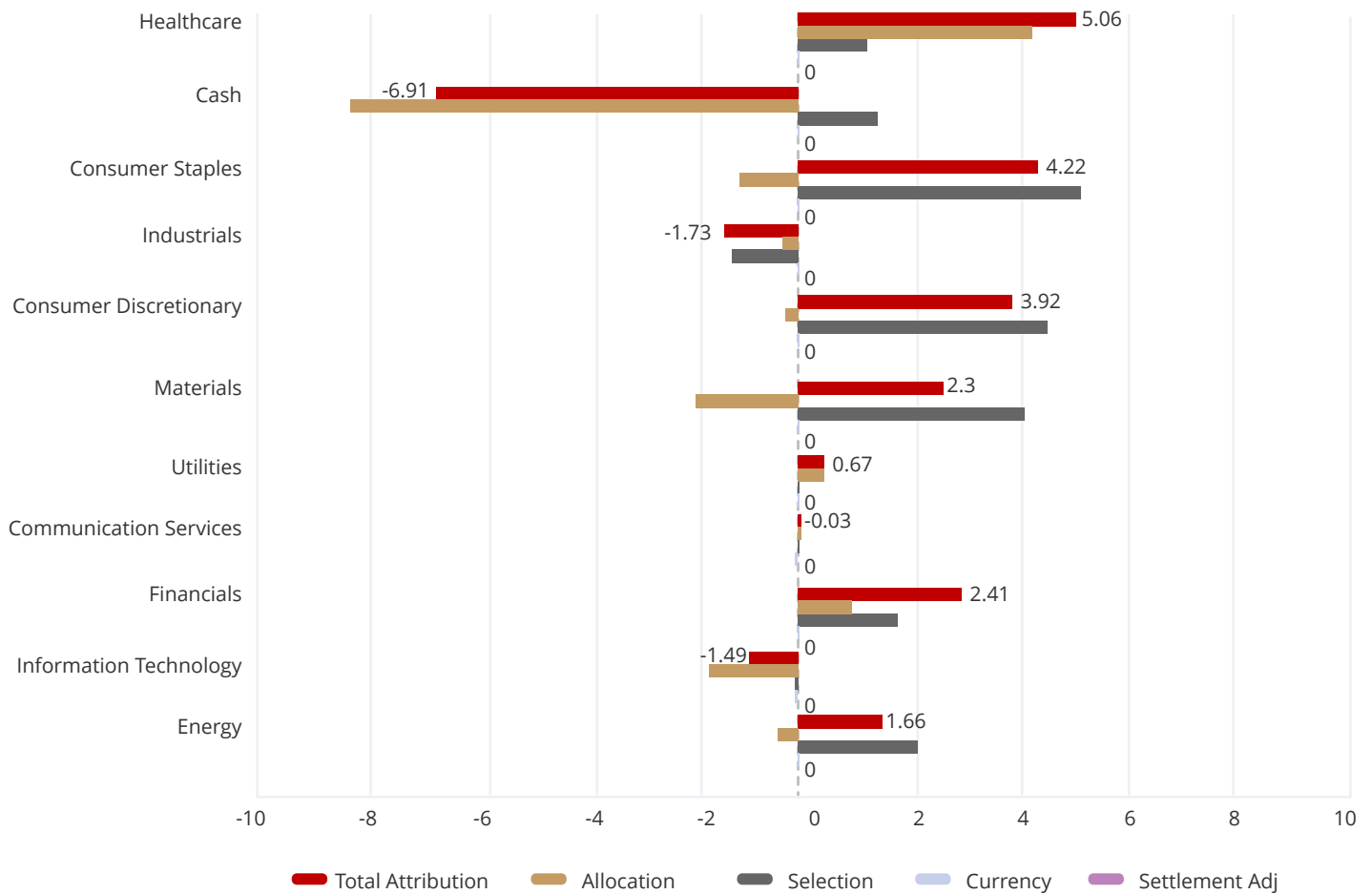
