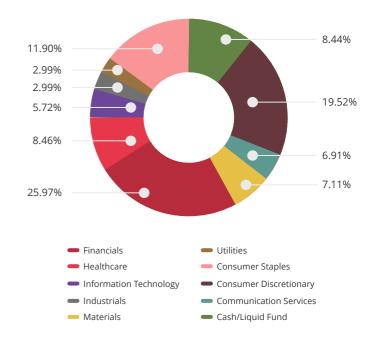

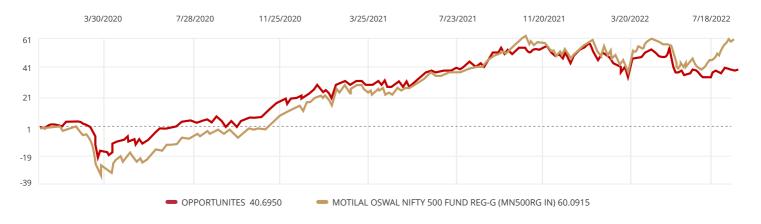

Performance: Model Portfolio: 31 August 2022

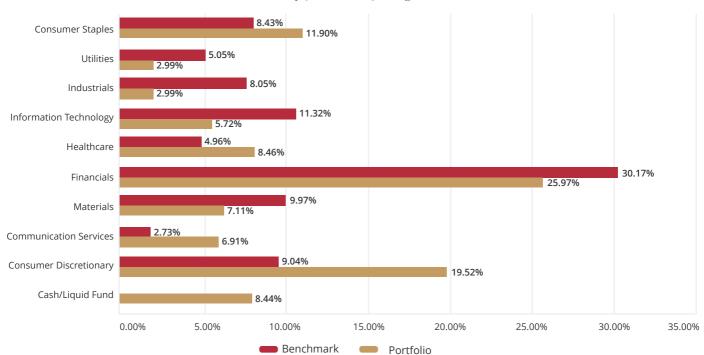

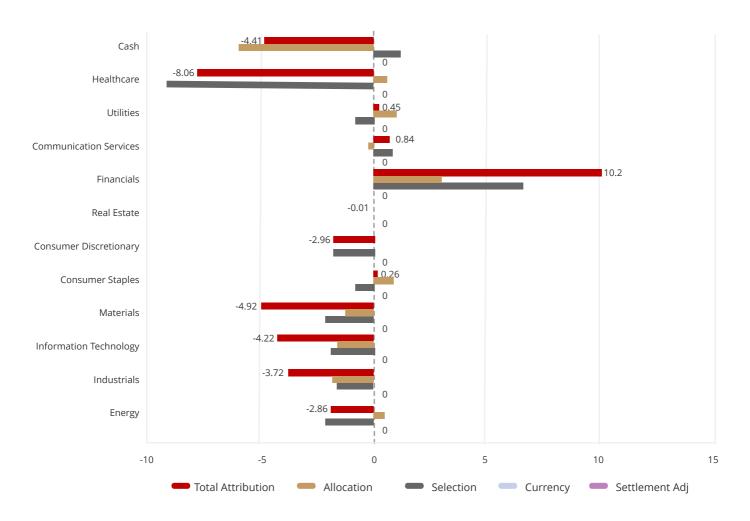
