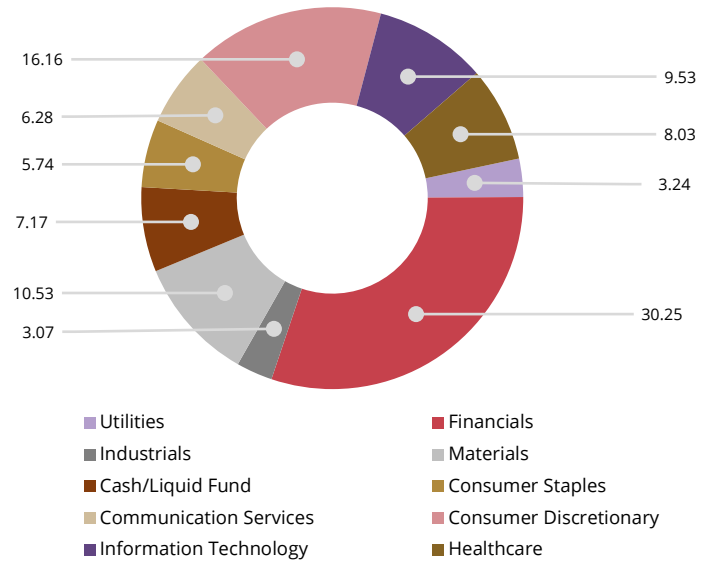

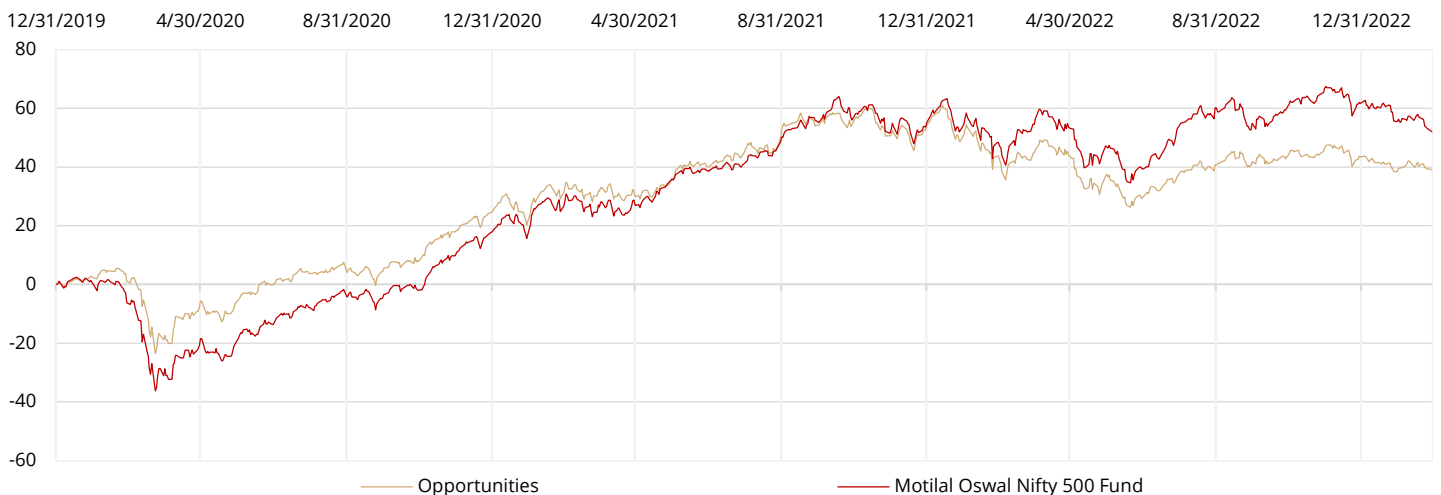

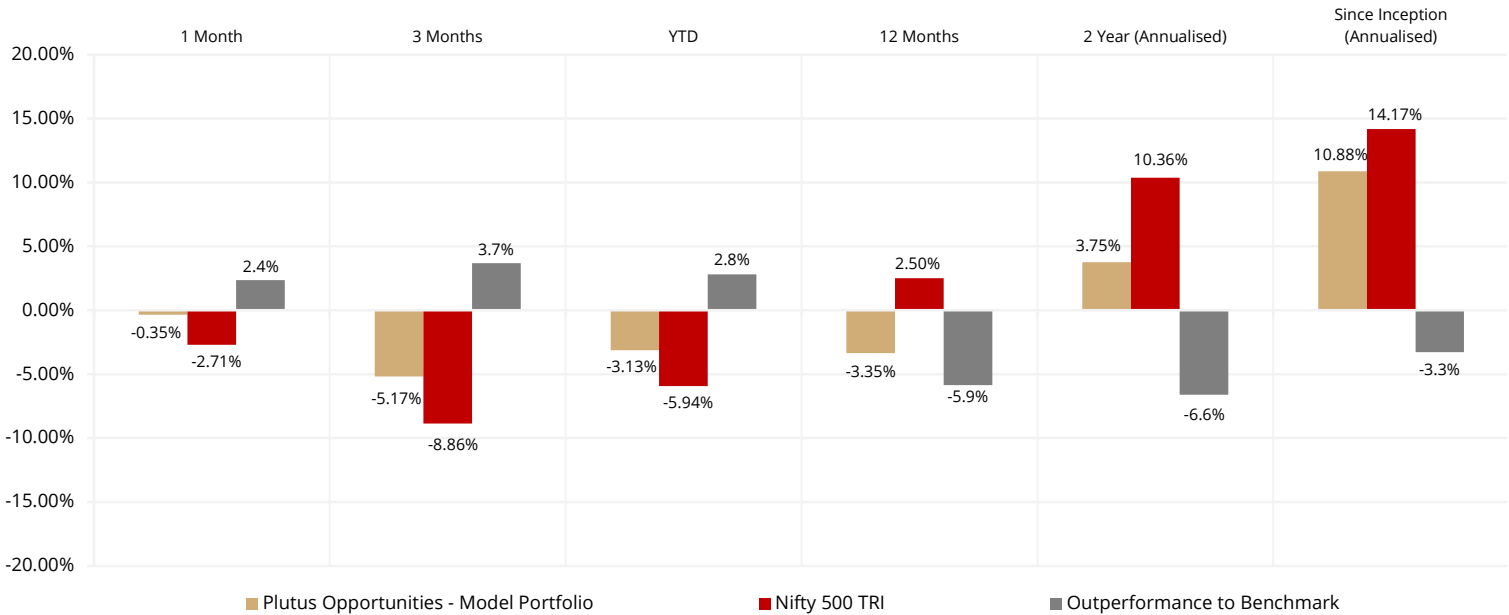
Model Portfolio weight: 28 February 2023

## Performance: Model Portfolio: 28 February 2023

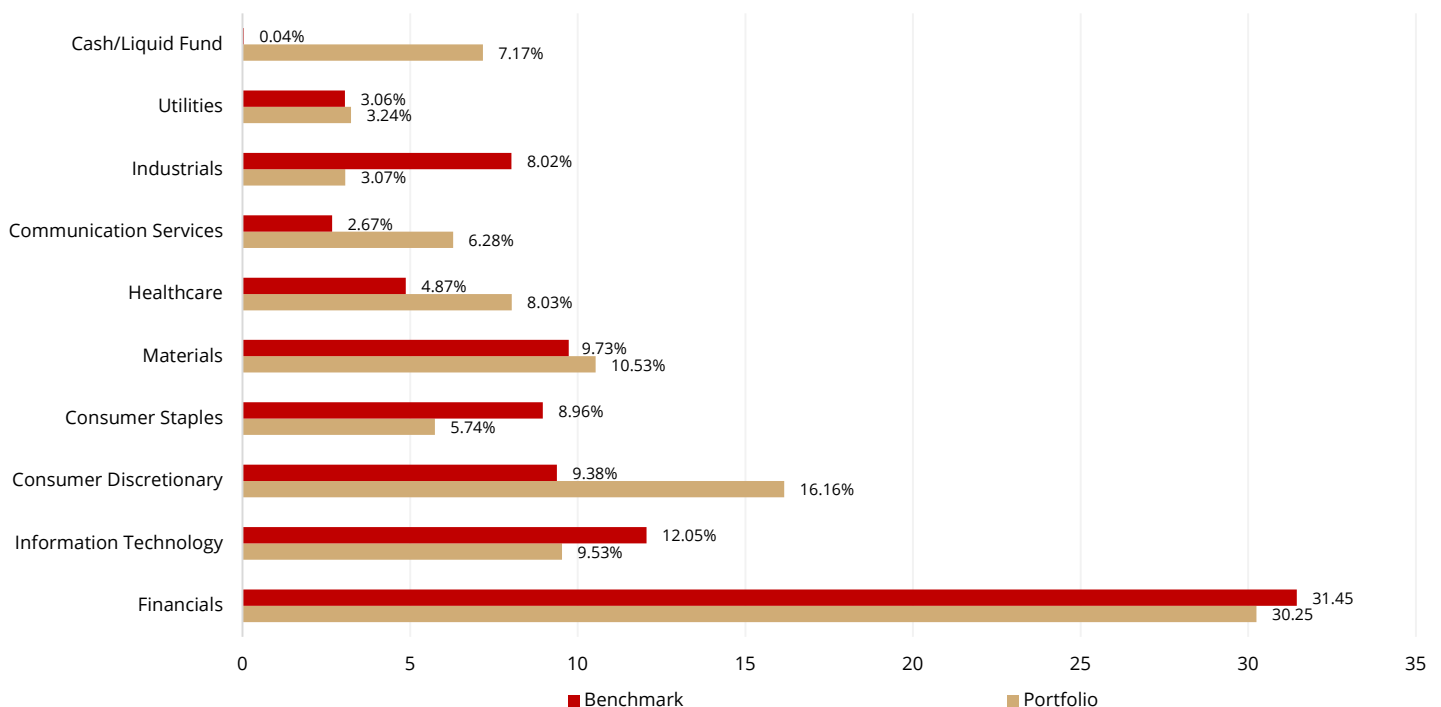

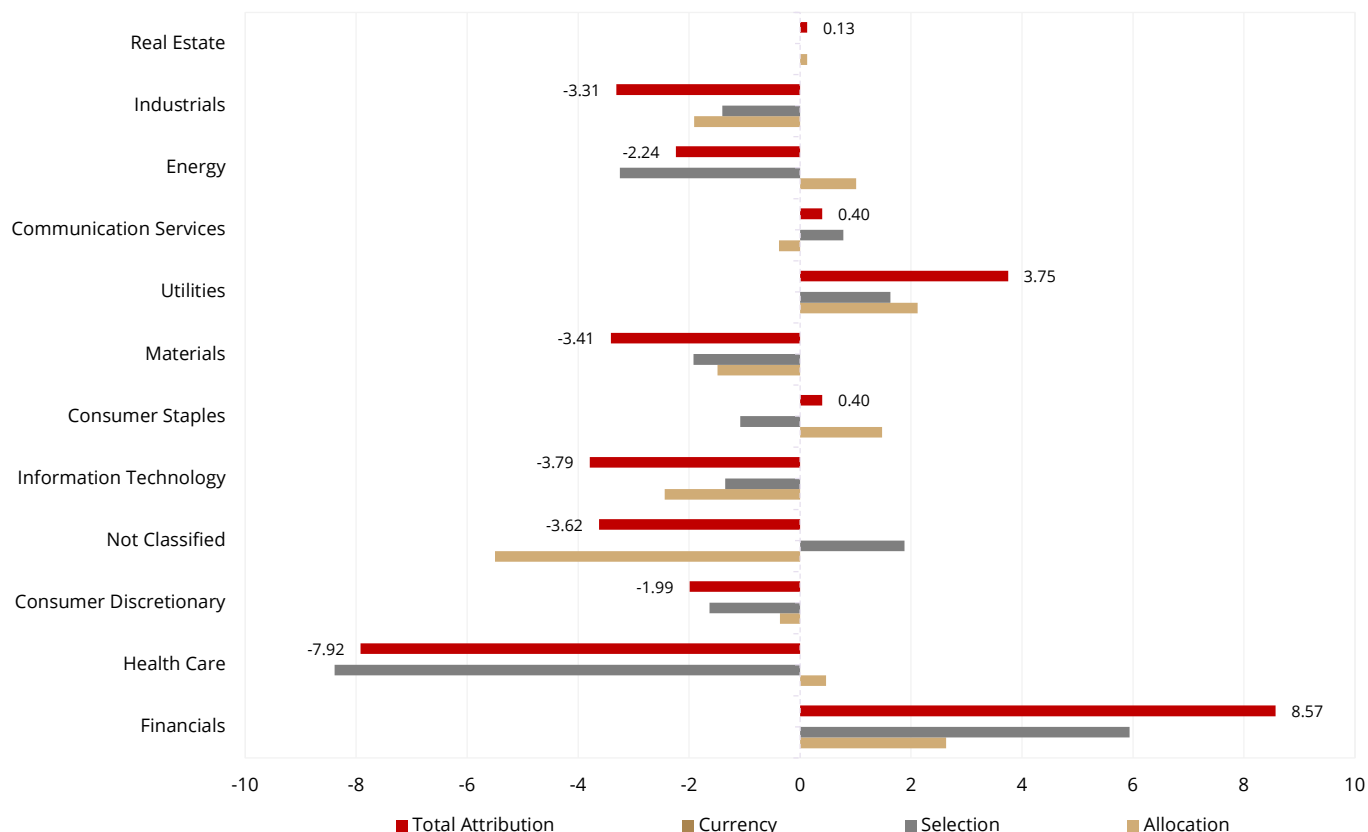
